



Anticipated revenues decreases by \$766,338 primarily due to a 100% decrease in Fund Balance utilized, as well as a decrease in budgeted grant revenue of \$450,000. Amount raised by taxes increases \$42,729

Salary & Wages- Operations increases \$262,650 due to the hiring of 4 additional full time firefighters. Fringe benefits- Operations and maintenance increase \$448,316 due to the increased personnel being hired, as well as double digit increases in costs of insurance for existing employees. Uniforms increases \$20,000, and training increases \$22,000 due to new hires. Maintenance & repair increases \$52,500 due to required repairs to aging apparatus. Fire equipment and Firefighting gear will increase \$97,500 due to the increase in personnel. Appropriations Offset with Revenues-Personnel and Miscellaneous will increase \$10,661 due to increased enforcement activity. Total capital Appropriations decreases \$1,700,000 in 2026 because of no new voter approved Capital spending .Email maintenance increase is due to additional hires requiring new e-mail boxes, along with additional cost & maintenance. Medical /Physical cost increase due to plan to hire new firefighters. Fire Equipment testing increases because of third new engine coming in 2026, along with increased hose testing . Communication & technology increases due to new firefighters needing new radios. M&R Building & Vehicles increases due to addition of 3rd engine to the fleet; another engine in the fleet is a lemon, not covered by lemon law protection, thus, more out of pocket costs to keep maintained.
